Overview

Social inequalities in health in Europe are not just a challenge; they are a call to action. Health outcomes are inextricably linked to our socio-economic context, education, living and working conditions and access to essential services. Addressing these factors is not merely a health imperative; it is essential for preserving Europe's social model and ensuring its competitiveness.

However, as the new report on 'Social Inequalities in Health in the EU' by EuroHealthNet and the Centre for Health Equity Analytics (CHAIN) confirms, the links between socioeconomic disadvantage and poor health remain persistent.

Following a high-level European policy debate hosted by MEP Vytenis Andriukaitis, on behalf of the European Parliament Interest Group on 'Health Inequalities, Prevention and Risk Factors' on 25 September, EuroHealthNet organises this public and expert webinar on **26 September 2025 from 10 to 12h30 CET** to discuss the report's national and subnational data and good practices in more depth.

The online workshop will bring together European, national and regional public health experts, researchers, policymakers and representatives from civil society.

The insights shared will support us all to champion integrated strategies that not only improve public health but also combat poverty and social exclusion.
